## 6. Arden Arcade Incorporation Proposal Status Report

## a. CFA Scope of Work Amendment for Annexation Analysis

The Arden Arcade Incorporation proponents missed a key payment deadline to initiate the Comprehensive Fiscal Analysis (CFA) and Environmental Impact Report (EIR) by July 1, 2007. Staff will continue to do their best to meet the November 2008 election deadline. However, payments need to be made on time so that the work is not delayed.

The Commission discussed various funding options for the CFA - A, B, C and D which each represent a different funding alternative for the Amended Scope of Work.

The proponents were informed that if payments are made according to the proposed schedule, LAFCo staff and the consultants will continue to make every effort to finish the project on time. However, due to other unforeseen issues that might come up, such as other delays, or information requests, there is no guarantee.

Commission Counsel stated "we've informed them that we do not think we can meet that schedule. We're going to continue to use every effort to do it, but the EIR consultant has already had to change the contract."

Motion: To direct staff to amend the CFA Agreement with the consultant to perform options A, C, and D. LAFCo will pay for options C and D not to exceed \$75,000; and the proponents will be required to pay for option A.
