This is an information only item. This status report is provided to keep your Commission informed of the various projects which your staff is managing.

Your staff proactively works with the full spectrum of agencies subject to LAFCo oversight. While the timing of various projects is subject to the resources and priorities of the various governing bodies, your staff collaborates early on and progressively, through each stage of project development, in order to expedite LAFCo proceedings.

The report begins with the "Month at a Glance" followed by a "Project Synopsis" for quick reference. The work plan is broken into several ongoing, parallel project management tracks, which provide more detailed information:

Staff's first priority is proponent applications. Next are near term projects, such as policy development for Commission adoption. The general program of Municipal Service Review and Sphere of Influence Updates will be conducted concurrently with all workload, as resources allow. MONTHLY ACTIVITY AT A GLANCE:

At the request of your Commission, we have included a recap of various project activities. This generally includes meeting preparation and immediate follow-up. Many activities are ongoing and evolving, and require commensurate staff time, other than that noted.

- O City of Elk Grove Sphere of Influence Amendment request (LAFC 04-08). 10,500+ acres south and southeast of city. Complete CEQA RFP and consultant interviews. Held internal project scoping meeting w/EIR consultant, LAFCo and city staff. Continue to discuss CEQA Project Description w/City staff. Attended April 14, 2010 City Council public hearing at the invitation of city staff. Council took action to amend application. No revision yet submitted.
- Ongoing consultation with County of Sacramento and City of Sacramento staff, as well as state and federal regulators, and consultants regarding Natomas Joint Vision General Plan Amendments and Sphere of Influence Amendment, environmental review process and overall coordination opportunities. Board of Supervisors established a SPA, and initiated efforts to address NBHCP to move ahead with next phase of analysis.
- Ongoing collaboration re: SB 375/AB 32 considerations w/SACOG staff regarding various annexation proceedings. Attend regional (six county) LAFCo staff meeting w/SACOG staff re: MTP update.
- o File Certificate of Completion for various recently completed proceedings.
- o Ongoing SacLAFCo.org website maintenance.
- O Consult w/staff of the CA Dept. of Public Health (CADPH) re: Grand Jury report for the RL/E CWD. Apparently the district has been effectively meeting the directives imposed by the Compliance Orders (#01-09-07-CO-004 & #01-09-09-CO-004.) Adequate financing appears to be of the greatest concern. The RL/ECWD has a loan application pending with the CADPH. LAFCo staff efforts to make contact with RL/ECWD staff have been unsuccessful to date.
- Ongoing implementation of office and procedure updates with Commission Clerk.
- Attend Inter-agency coordination lunch w/County and City of Sacramento to staff.
- Attend Annual CALAFCO Staff Workshop.
- o Ongoing collaboration w/SASD and SRCSD staff regarding wastewater collection and treatment infrastructure planning.

- o Continue discussions w/City of Sacramento regarding Freeport/Bartley Cavanaugh G.C. annexation and Panhandle Reorganization.
- Panhandle Reorganization discussed annexation and property tax exchange processes w/City staff.
- Arden Arcade Inc. Circulate DEIR and DCFA for public review and comments. Prepare for May 5, 2010 Commission Hearing. Finalize FEIR and FCFA.

Staff will report back in February with proposed modifications to locally adopted Sacramento LAFCo Municipal Service Review Guidelines and the Municipal Service Review Request for Information (RFI) Worksheet and Questionnaire, in order to implement the new law. In the interest of moving the ahead with the MSR Workplan, we will continue to use the current format until the updates are adopted.

- 2. Camino Norte (formerly 49'er Truck Stop) Reorganization Annexation to City of Sacramento (I-80 and El Centro Road). Ongoing consultation with City of Sacramento staff.
- 3. Formation of Long Island Community Services District.
- 4. Florin Resource Conservation District Annexation of Susan B. Gains Building (11-03) (within City of Sacramento) Proposal to annex single parcel to District. Proposal withdrawn by proponent.
